Copyright Transfer Agreement for CeROArt Journal



CeROArt is hosted on the OpenEdition platform, whose licensing policy is based on the Creative Commons 4.0 (CC) License. By default, the platform applies the CC BY-NC-ND 4.0 license to our Journal, issues (or annual sections), and documents it hosts. We adhere to the Diamond Open Access model, a free, community-driven, and non-commercial academic publishing model with no financial barriers for authors and readers. This copyright transfer agreement fully aligns with this non-commercial approach. It is freely inspired by the model defined by ICOM-CC for its online platform.

Title of the document or article: Hereinafter referred to as "the contribution."

This agreement aims to protect the interests of CeROArt as well as those of the authors and their employers while establishing a fair balance between the rights of both parties.

I. Copyright Transfer

a) The undersigned hereby transfers to CeROArt, for the entire duration of the copyright from the date of acceptance of the work for publication, as well as any extension or renewal of that duration, all copyright related to the contribution, including, but not limited to, the right to publish, republish, transmit, distribute, and use the contribution and its materials (including abstracts, tables, graphics, images, etc.), in electronic and printed editions and in derivative works worldwide, in all languages and through all means of expression known today or developed in the future, and to grant licenses or allow others to do so. The undersigned expressly acknowledges and agrees to the inclusion of their name, email address, and institutional affiliations in the registered

version of the contribution. The undersigned expressly agrees to the inclusion of the contribution's abstract, if applicable, in the AATA Online bibliographic database and to comply with AATA's general terms and conditions, as amended from time to time.

b) Any reproduction, display, transmission, or other distribution or use of the contribution or any of its elements, on any medium authorized herein, must include the standardized electronic reference as indicated in the online publication, as well as the DOI link, as shown in the example below:

II. CeROArt Restitutes Rights to the Author(s)

- a) The right, free of charge, to photocopy, transmit online, download, print, and distribute a copy of the published contribution, in whole or in part, to a colleague for the personal or professional use of the author, for the advancement of research, academic or scientific studies, or for corporate informational purposes, in accordance with section III.b) below.

If the contribution contains excerpts from works protected by third-party copyrights, the author certifies that they have obtained written permission from the copyright holders for all uses intended within the scope of CeROArt's publication. The author commits to citing sources within the contribution.

The author certifies that the contribution is free from defamatory, obscene, or unlawful statements. It does not infringe on any existing rights related to privacy, copyright, trademarks, or any other intellectual property rights.

VI. Dispute Resolution

This agreement is governed by Belgian law. In the event of a dispute regarding its interpretation, execution, or validity, the parties shall endeavor to reach an amicable resolution.

If no amicable agreement is reached within **30 days** from the written notification of the dispute by one of the parties, the matter shall be submitted to the competent courts of **Liège**, unless otherwise required by law.
